## PERFECT FOR

Individuals seeking up to \$3,000,000 of liability insurance.

Liability insurance provides funds for covered losses including defense costs arising from injury or damage to another person or property.

In New York State, just about anybody can be targeted by a lawsuit. Homeowners, auto and watercraft insurance provides liability coverage up to a published limit on each policy. The Security Mutual Insurance Personal Umbrella Policy is triggered when the limits on existing or underlying policies are exhausted.

Without a Personal Umbrella Policy, you will be financially responsible for major claims and lawsuits greater than the limits of liablity in your underlying insurance policies.

If you own property and/or have assets that are worth more than the liability limits covered by your basic policies, ask your independent agent about a Security Mutual Insurance Personal Umbrella Policy.

#### **INELIGIBLE CLASSES**

Politicians, public lecturers, radio and television broadcasters, newspaper editors and reporters, labor leaders, any prominent public figures, law enforcement officials (some exceptions apply, contact company). Any driver with two or more moving violations or chargeable accidents in a three-year period; or a conviction of driving while intoxicated or reckless driving within the past ten years.

### INELIGIBLE EXPOSURES

- · Additional insureds, non-resident drivers
- · Bed and Breakfast exposures, with more than four rooms held for rental
- · Home Day Care exposures, with more than three children
- Jet Skis, 1 2 passenger exceeding 100 HP/900 cc
- Jet Skis, 3 4 passenger exceeding 120 HP/1000 cc
- Pools, risks with unfenced, in-ground pools or above ground pools (including temporary inflatables) without a removable ladder; deck with gate; or any pool with a slide
- Skateboard Ramps
- · Trampolines, unless netted; fenced-in; tied down; and above a soft surface

### MINIMUM REQUIRED UNDERLYING LIMITS
